

***** NOTICE *****

Failure to make your election and submit payment within thirty (30) calendar days will result in additional penalties of \$18 and possible suspension of your driving privilege.

****DRIVER IMPROVEMENT SCHOOL****

You may not elect driver improvement school if:

1. You are a holder of a CDL driver's license.
2. You have already submitted payment in full without the traffic option form.
3. Payment of reduced fine and traffic option was not submitted within thirty (30) calendar days from the date of your citation.
4. You have made this election in the last twelve (12) months or (5) five times in your lifetime.

Failure to attend school and return your certificate of completion to the Clerk of Circuit Court of Sarasota County within ninety (90) calendar days from the date of your citation will result in points being assessed to your driver's license, additional penalties of \$18.00, and possible suspension of your driving privilege. ****TAG, REGISTRATION, DRIVER LICENSE, OR INSURANCE****

If you are charged under §320.07(3)(a), §320.0605, §322.03(1), §322.15(1), or §316.646(1) of the Florida Statutes your ticket may be dismissed by providing proof of a valid registration, driver license or insurance card along with a \$7.50 payment within thirty (30) calendar days from the date your citation was issued. The registration, driver license or insurance must have been valid at the time the citation was issued.

****DISABLED PERMIT OR LICENSE TAG****

If you are charged under §316.1955 of the Florida Statutes, you must provide proof of valid parking permit or license plate to the Law Enforcement agency that issued you the citation. The Law Enforcement agency is responsible for providing an Affidavit of Compliance, which must accompany your payment of \$7.50 within thirty (30) calendar days from the date, your citation was issued in order for the charge to be dismissed.
