Section I: Disqualification

- ☐ I do not possess a valid FL Driver License or Identification card or have not requested to serve as juror by affidavit.
- ☐ I do not reside in Sarasota County.

- ☐ I am under prosecution for a crime.

Section II: Exemption Request

- ☐ I am an expectant mother or a woman who has given birth within the 6 months before reporting date.
- ☐ I am a parent who is not employed full-time and has custody of a child under 6 years of age.
- ☐ I am a person responsible for the care of another incapable of caring for themselves.
- ☐ I am 70 years of age or older and wish to have a permanent excuse. (This selection will eliminate future jury summons.)
- ☐ I am 70 years of age or older and wish to be excused at this time.
- ☐ I am permanently incapable of caring for myself. (Must attach letter from physician)
- ☐ I am a full-time law enforcement officer or among such entities' investigative personnel.
- ☐ I have served as juror in Sarasota County within the last 365 days.
- ☐ I am a full-time student between the ages of 18-21.
